2. OPENING REMARKS

AMacI thanked all for their attendance this evening. He stated he had emailed GMR to invite him to this evening's meeting. There was no response, and his vacant seat will be advertised in the new year.

There had been correspondence regarding scoping for the Pylons, this was sent to the old BDCC address. AMacI has contacted the Scottish Government, this has been resent to the correct address and circulated, with an extension to the deadline for any comments.

Brora CC had attempted to contact BDCC, AMacI has emailed them with correct address.

AMacI has contacted Liam C and Phil T (HC) regarding the incorrect contact information on the HC website, he was informed this would be corrected.

4. POLICE

- **a. Police Report:** No report received from Police Scotland. AMacI will make contact with new chief inspector at AOCC meeting.
 - Comments from members of the public, that dangerous overtaking is still taking place on the A9 northside of bridge, where new chevrons have been marked on the road.
- **b. Speed Display Sign:** NB has emailed Transport Scotland for permission to install awaiting a reply.

5. COMMUNITIES & PLACE

- a. Dunbeath Strath Bridge temp. closure: Informed that this is still ongoing due to uncertainty of who owns the bridge. HC have offered to temporarily repair the bridge, landowners have declined this offer due to is being a temporarily fix and ownership needs to be discovered AMacI and JI will communicate with Dunbeath Estate regarding this.
- **b.** Dog Signage This has been ordered JI to give DM invoice.

- c. Cooper's Path: AMacI and JI attended a meeting with Charlotte (Savills) Dunbeath Estate. This was highlighted at the meeting. Further discussions to be had after Charlotte speaks with Matt Dent,
- d. Phone Box Dunbeath Harbour: AMacI has spoken with DPT and they will move the phone box
- **e. Interpretive panels Dunbeath Harbour:** DPT have provided an invoice for this project. This was given to DM for payment to be issued.
- f. Dunbeath Playing Fields grass cutting: Remove until Spring 2025
- **g. Benches, Mill Carpark** AMacB stated that the DPT may have two benches that can be installed here. She will confirm.
- h. Village Maintenance: It has been confirmed that the payment from HC will be £700, NB has completed an invoice to show estimate costs of grass maintenance that is kindly done by members of the public, this invoice doesn't include travel costs, fuel and maintenance to machinery. It was agreed for a funding application to be completed for LLCDCC fund, closes end January 2025.
- i. Berriedale and Dunbeath Locality Plan: This has been produced by HC for Berriedale, Dunbeath, Latheron & Lybster. The indications for improvements were Employment, transport, broadband, childcare, lack of affordable housing.
